

## Institut de Recerca de l'Hospital de la Santa Creu i Sant Pau: Marie Sklodowska-Curie Postdoctoral Fellowships (PF) 2022 Hosting Offers

Are you a post-doctoral researcher thinking about your next career move? The Marie Sklodowska-Curie (MSCA) Postdoctoral Fellowships may be just right for you. These fellowships fund researchers looking to enhance their career development and prospects by working abroad.

The Research Institute of the Hospital de la Santa Creu i Sant Pau is willing to host post-doctoral MSCA-PF 2022 applicants, mainly with the modality European Postdoctoral Fellowships.

### A few tips about the Postdoctoral Fellowships

The objective of PFs is to support researchers' careers and foster excellence in research. The Postdoctoral Fellowships action targets researchers holding a PhD who wish to carry out their research activities abroad, acquire new skills and develop their careers. Interested researchers submit an application together with a host organization.

There are 2 types of Postdoctoral Fellowships:

1. **European Postdoctoral Fellowships.** They are open to researchers moving within Europe or coming to Europe from another part of the world to pursue their research career. They can last between 1 and 2 years. Researchers of any nationality can apply.
2. **Global Postdoctoral Fellowships.** They fund the mobility of researchers outside Europe. The fellowship lasts between 2 to 3 years, of which the first 1 to 2 years will be spent in a non-associated Third Country, followed by a mandatory return phase of 1 year (to the Research Institute of the Hospital de la Santa Creu i Sant Pau in our case). Only nationals or long-term residents can apply.

Both types of fellowships may also include short-term secondments anywhere in the world during the fellowship (except during the return phase of a Global Fellowship). Researchers can receive additional support to carry out a placement of up to 6 months in a non-academic organisation, at the end of their fellowship.

### Who can apply?

- ✓ Promising researchers from anywhere in the world: all nationalities can apply.
- ✓ Mobility is a must: you have to come to Europe or move within Europe (for European Postdoctoral Fellowships) or move outside of Europe (for Global Postdoctoral Fellowships).
- ✓ All areas of research.
- ✓ Candidates must hold a PhD at the call deadline (14 Sept. 2022) and have 8 years maximum of full-time research experience after the PhD.
- ✓ "Mobility rule" for European Postdoctoral Fellowships: candidates must NOT have resided or carried out their main activity (work, studies, etc.) in the country of the beneficiary for more than 12 months in the 36 months immediately before the call deadline.
- ✓ Although not an eligibility criterion, a good track record is recommended.

### I'm interested. What should I do?

1. Check the list of hosting offers posted by the Research Institute of the Hospital de la Santa Creu i Sant Pau. Think if a domain fits your profile or seems complimentary to your expertise.
2. If you think you could have an interesting research project idea that fits the domains described in one of our hosting offers, complete the application form. Please, take into account that only candidates that meet the MSCA-FP 2022 application requirements (such as the so-called 'mobility rule' or the maximum number of previous research experience) will be considered for proposal supervision.
3. That's it for now! Based on the info you provided we will get back to you regarding the next steps.

### Instructions for the CV

#### CV of the researcher (indicative length: 5 pages)

Always mention full dates (using format: dd/mm/yyyy). The CV should include the standard academic and research record. Any research career gaps and/or unconventional paths should be clearly explained.

At a minimum, the CV should contain:

- a) The name of the researcher;
- b) Professional experience (most recent first, with exact dates in format dd/mm/yyyy);
- c) Education, including PhD award date (most recent first, with exact dates in format: dd/mm/yyyy).

The CV should include information on:


- Publications in peer-reviewed scientific journals, peer-reviewed conference proceedings, and/or monographs (they are expected to be open access either published or through repositories) and other outputs such as data, software, algorithms significant for your research path (they are expected to be open access in appropriate repositories to the extent possible; they should be accompanied by a very short qualitative assessment of their scientific significance and not by the Journal Impact Factor);
- Invited presentations to internationally established conferences and/or international advanced schools;
- Organisation of international conferences, including membership in the steering and/or programme committee;
- Research expeditions led by the researcher;
- Granted patent(s);
- Examples of participation in industrial innovation;
- Prizes and Awards;

- Funding received so far;
- Supervising and mentoring activities;
- Other items of interest.

Applicants who have successfully defended their doctoral thesis before the call deadline but who have not yet formally been awarded the doctoral degree must clearly indicate the date of the successful PhD defence (“viva”). Researchers having their last thesis defence after the call deadline will be automatically declared ineligible for this call.

### How to submit the application

The form can be saved (button save). You will receive an email with your user and password to enter again into the portal.
